Massachusetts General Law 44 §53G, 166 South Shelburne Road: The Commission received an Abbreviated Notice of Resource Area Delineation (ANRAD) application for the wetland delineation at 166 South Shelburne Road (Map R40, Lot 12). The public hearing is scheduled to open on November 22, 2016. The Delineated wetland resource areas included Isolated Vegetated Wetland (IVW), Bordering Vegetated Wetland (BVW), Bank, and Mean Annual High Water (MAHW) of a mapped perennial stream, known of Smead Brook. The Commission discussed whether to exercise their right to use a third party review for the wetland delineation.

Pollock stated the applicant may reduce the scope of wetlands to be delineated pending the Commission's decision to use a third party review.

Mosher stated if the applicant does not include all the wetlands for delineation now, they will most likely need to delineate them if they move forward with filing a Notice of Intent for demolition and construction.

Mosher stated he supports the use of a third party review. Stated there has been an ongoing drought, the leaves have fallen for the year, and it may be difficult to delineate the wetlands at this time.
