- Brian Munier - wants to open bakery on 282 Main St. - concerned about getting inspection when open. Came to find out who would be able to inspect within a month. Steve does not know what to tell him. Has call to MAHB did not get back to Steve. We need your business in town. Steve will give Brian his

contact info. Have contacted the state and they have a problem with the people in other areas MA due to the gas explosions, therefore they have no one to help.

- John Bednarski angry for what is happening in the health department - lives here and wants his family safe here. Dr. Doyle agreed very annoyed at this situation. Board of Health has had a good role of policy and prevention in the past.
- Future of BOH/ Health Dept - Steve has a suggestion he wants to discuss with the mayor, get in someone temporarily. Steve asked if Board members want to resign, as all are angry at town council. All decided to stick it out.


