MRVP/Section 8 - \$75.00 per unit

- ∴ Dwelling unit inspection in addition to common areas
- ∴ Re-Inspection (if required) 2nd and subsequent inspections will be charged a \$50.00 fee
- ∴ Certificate of Fitness for Human Habitation

Pre-Rental Inspections Program

How do I benefit ?

Landlord benefits:

- * Receive guidance on housing code requirements from public health professionals.
- * Documentation of the conditions of the rental unit at the beginning of the tenancy.
- * Protection against consumer lawsuits for renting sub-standard units.
- * A tool that can be utilized against illegal rent withholding and tenant damage to the unit.
- * Marketable units to interested renters.

Tenant benefits:

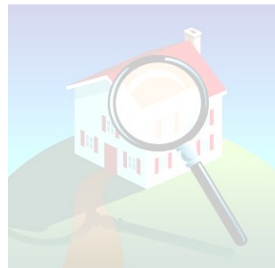
- * Provided with a legal, safe, and sanitary apartments.
- * Education on their responsibilities and rights.

Community benefits:

- * Proper care and maintenance of residential properties.
- * Promotes healthy homes that protects children, seniors, and other occupants.
- * The legal and proper use of dwellings in accordance with zoning, building, and sanitary codes requirements.

Inspection

By requesting a pre-rental inspection you are allowing the Greenfield Health Department to conduct a full housing inspection. The inspection will be conducted in accordance with Chapter III Sections 127A and 127B, of the Massachusetts General Laws, 105 CMR 400.000: State Sanitary Code, Chapter I: *General Administrative Procedures*, and 105 CMR 410.000: State Sanitary Code, Chapter II: *Minimum Standards of Fitness For Human Habitation*.



Requesting an Inspection

The landlord or authorized agent may request a pre-rental inspection. This inspection is different than a general complaint. A pre-rental inspection must be conducted within 30-days of the start of a lease or within the first 30-days of occupancy.

Certificate of Fitness

When the inspection has been completed an Inspection Report will be issued to the owner or property manager. A timeline will be given and a re-inspection will be required. Once the unit has been cleared the owner and tenant will receive a Certificate of Fitness. The certificate does not mean that a future call or complaint can not be reported to the Greenfield Health Department. It states that at the time of the inspection the unit was fit for habitation and complied with Mass Housing Code Standards.
