**MOTION:** On a motion by Councilor Maloney, second by Councilor McLellan, it was unanimously,  
**VOTED:** THAT THE GREENFIELD TOWN COUNCIL WAIVE THE RULES OF PROCEDURE, RULE 8, ORDER AND DISPOSITION OF BUSINESS.

- Appropriate \$14,732.40 from Overlay Surplus to Refund of Taxes.
